### By Using Our Website, You Accept These Terms and Conditions

- 15.2 Any dispute arising out of or in connection with this contract, including any question regarding its existence, validity or termination, shall be referred to and finally resolved by arbitration under the Arbitration Rules of the DIFC – LCIA Arbitration Centre, which Rules are deemed to be incorporated by reference into this clause. The number of arbitrators shall be three. The seat, or legal place, of arbitration shall be DIFC. The language to be used in the arbitration shall be English. The governing law of this arbitration agreement shall be the substantive law of DIFC.
- 15.3 The previous Clause shall not preclude the making of an application to any competent court for injunctive relief.
